**Drive against Illegal use of electricity.**  
**Task Forces of Mardan Circle in action**

On the directions of Chief Executive PESCO, Task Forces actions against illegal use of electricity and Recovery of dues with the cooperation of Federal and Provincial Govt has been geared up throughout the Province. In this connection Task Forces in Mardan Circle checked various areas of Takhtbai Division. During the operation 26 direct connections has been removed. Rs.251483/- has been recovered from Permanent disconnected defaulters while Rs.205156/- has been recovered from running consumers. 5 defaulters have been arrested due to nonpayment.

Similarly Task Force of Mardan-2 Division checked various areas in Mardan. According to detail checking teams of PESCO Par Hoti sub division checked the premises in Ali Kali, Rustam, Darbi Adda, Chargolai, Gujrat, Zandu, Zarif Khan dheri nabbed 14 persons for taking direct connections. FIR has been lodged against them. Rs.0.67 Million has been recovered. 3 LT spans has been disconnected in Akhun Baba Kili due to nonpayment. Similarly checking teams of Gojar Ghari sub division checked the areas of Sharifabad and removed 10 direct hooks. FIRs have been registered against them in the concerned police station. Rs. 1,86 Millions have been recovered from defaulters.

Drive against illegal use of electricity and direct hooks will continue, PESCO has once again warned to stop power pilferage in the larger interest of the nation, due to which PESCO has to face financial losses & line losses on one hand and on the other hand PESCO's whole distribution system gets over loaded and the general public faces inconvenience of frequent power break downs.
