**TERMS & CONDITIONS**

- i. The Prices should be firm and final on FCS basis without involving any foreign exchange.
- ii. Tender must be accompanied by Bank Guarantee for an amount not less than 2% (Two Percent) for registered firm with WAPDA/PEPCO & 04 for unregistered Firm (For Tender No.02 only) of total tender value to be valid for 180 days (one hundred and eighty) in the form Bank Guarantee / Call Deposit/Pay Order issued by any schedule Bank of Pakistan.
- iii. Tender form can be obtained from the office of Manager (MM) PESCO against non-refundable amount of Rs.2000/- per tender on any working day during office hours till a day earlier from the opening of the tender.
- iv. Tender will be received manually and will be dropped in tender box at the time mentioned against each. However a representative should be present at the time of opening. PESCO will not be responsible if tender received via courier after opening date & time. The bidder must ensure that their bid was dropped in tender box well in time.
- v. There will be no sale of tender documents on the date of opening of tender.
- vi. Copy of renewal of registration / pre-qualification with any DISCO/PEPCO/(WAPDA), & registration with sales tax Department (For tender No. 02 registration with sales tax department should be provided in case the firm not registered with PEPCO/WAPDA) should be produced at the time of issuance of tender documents/bid schedule.
- vii. **For Tender No.02, Authorized Active HP Partnership Certificate** should be provided for Item at S. No 1,2,4,5 & 6 at a time of issuance of tender documents (Which will be verified from the Principal if required) otherwise bid will be considered as non-responsive.
- viii. Bidder must quote full quantity of the item.
- ix. The Firm must provide MAL (Manufacture Authorization Letter) in the favour of PESCO for Tender No.02 otherwise bid will be considered as non-responsive.
- x. For Tender No. 01, The Firm/Manufacturer must be registered with PEPCO/WAPDA/DISCO,s.
- xi. Tender and Bid Validity will be 180 days from the date of opening of tender.
