Material shall confirm to relevant PEPCO/WAPDA Specifications (amended to date).

## **TERMS & CONDITIONS**

- i. **As per Rule 36(b) of the PPRA Rule, Single Stage Two Envelope Bidding Procedure will be adopted.** The bid shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the financial proposal and the technical proposal. The envelopes shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion. Initially, only the envelope marked "TECHNICAL-PROPOSAL" shall be opened. The envelope marked as "FINANCIAL PROPOSAL" shall be retained in the custody of PESCO without being opened. The financial proposals of bids shall be opened publicly at a time, date and venue announced and communicated to the bidders in advance; After the evaluation and approval of the technical proposal (sample selection) the procuring agency, shall at a time within the bid validity period, publicly open the financial proposals of the technically accepted bids or selected sample only. The financial proposal of bids found technically non-responsive or sample not selected by committee shall be returned unopened to the respective bidders and the selected sample or samples found to be the lowest evaluated bid shall be accepted.
- ii. Bid must be for full quantity of the item.
- iii. The Prices should be firm and final on FCS basis without involving any foreign exchange.
- iv. Tender must be accompanied by Bank Guarantee for an amount not less than 2% (Two Percent) for registered firm with WAPDA/PEPCO & 04% for unregistered Firm, of total tender value to be valid for 180 days (one hundred and eighty) in the form Bank Guarantee / Call Deposit issued by any schedule Bank of Pakistan.
- v. Tender form can be obtained from the office of Manager (MM) PESCO against non-refundable amount of Rs.1000/- per tender on any working day during office hours till a day earlier from the opening of the tender.
- vi. Tenders will be received manually and will be dropped in tender box at the time mentioned against each. However a representative should be present at the time of opening,
- vii. There will be no sale of tender documents on the date of opening of tender.
- viii. Copy of renewal of registration / pre-qualification with any DISCO/PEPCO/(WAPDA), or registration with sales tax Department should be produced at the time of issuance of tender documents and with your bid schedule.
- ix. Tender and Bid Validity will be 180 days from the date of opening of tender.
- x. Conditional tender will not be accepted.
- xi. Inspection charges if any will not be reimbursable.
- xii. In case holiday announced by the GOVT of Pakistan, strike in PESCO or any other reasons what so ever due to which this office remains closed on the above schedule tender opening date, the tender will be opened on next working day at the same time and place/venue.
